(Any substitutions or deletions may result in the forfeit of the bid).

- Bidder Name, mailing address and phone number.
- Vendor bid amount and any special conditions that may be set forth.
- A Bid Bond shall be furnished with the bid when submitted as required by Alabama Statute 39-2-4 in the amount of 5% of the total cost of the project. (If the projected bid is less than \$10,000, then a bid bond is not required)
- Bidder must have a current business license with the City of Southside, or must purchase one if vendor is awarded the project.
- Bidder must comply with the occupational tax requirements of the city.
- Bidder must complete a W-9 form verifying Federal ID# and or Social Security Number for 1099 purposes if not incorporated.
- The successful bidder must provide a certificate of insurance listing general liability and worker's compensation insurance within the limits listed in the specifications.
- All bidders are required to be a licensed general contractor in the State of Alabama and should provide a copy of their license
- The successful bidder must provide all bonds and meet all requirements established by the specifications.
- All bidders must have a minimum of five (5) years' experience with the installation of the products specified. Bidders must provide proof of experience by furnishing information on qualified projects of equal or greater size if requested by the City of Southside.
- The City of Southside reserves the right to waive any omissions and/or technicalities during the bidding process if it is determined to be in the best interest of the City of Southside.
